My doctoral thesis examines the coalescence of reproduction and conflict in Gilgit Town, economic and administrative capital of Pakistan's semi-autonomous, federally neglected and multi-sectarian Northern Areas. Specifically, my research explores the relationship between Shia-Sunni conflict, interpersonal enmities and Sunni Muslim women's reproductive and maternal health. Ethnographic fieldwork was conducted for 14-months among Sunni women, Gilgit's biomedical, traditional and Islamic therapeutic service providers, and at household, community, mosque and clinical-settings. My analysis addressed the physical, symbolic and cosmological threats that women perceived were interwoven with their fertility, pregnancy and childbirth-related health. Secondary analysis involved gendered sociality, Shia-Sunni militarism and the impacts of Islamic conservatism to women's health service uptake or everyday reproductive and maternal health practices and beliefs.
